### **ORDER:-**

In the Government order first read above, the Government had approved the programme of imparting Capacity Building and other training activities to the office bearers of Self Help Groups / Panchayat Level Federations /Habitation Level Forums among others under Mahalir Thittam and an amount of c.56,26,72,675/- had been sanctioned for the financial year 2010-11.

2. The Managing Director, Tamil Nadu Corporation for Development of Women Limited in the letter second read above, has requested the Government to sanction an additional amount of c.1,42,74,225/- for undertaking the Capacity Building and other training activities to the office bearers of Panchayat Level Federation /Habitation Level Forum additionally due to the following reasons:-

- (i) During the financial year 2010-11, a total of 3,780 Panchayat Level Federations would be restructured. Out of these, it was initially proposed that 2835 Panchayat Level Federations would be restructured in the first three quarters would become eligible for imparting capacity building trainings.
- (ii) Normally, the capacity building trainings will be imparted to 945 Panchayat Level Federations formed in the fourth quarter in the beginning of the next Financial year i.e, 2011-12.

(iii) The Tamil Nadu Corporation for Development of Women Limited has been instructed to achieve the fourth quarter target for restructuring of 945 Panchayat Level Federations within the third quarter i.e, before December 2010 and the Capacity Building trainings have also to be imparted to these 945 Panchayat Level Federations within this financial year 2010-11.

3. The Government after careful examination, accept the proposal of Managing Director, Tamil Nadu Corporation for Development of Women Limited and sanction is accorded for release of a sum of c.1,42,74,225/- (Rupees One crore forty two lakhs seventy four thousand two hundred and twenty five only) being the additional amount for taking up of Capacity Building and other training prescribed for the office bearers of Panchayat Level Federations / Habitation Level Forums in the fourth quarter of current financial year itself, which are being formed during 2010-11.

4. The amount sanctioned in para 3 above shall be debited to the following heads of account.

5. The additional expenditure of c.1,42,74,225/- (Rupees one crore forty two lakhs seventy four thousands two hundred and twenty five only) involved in this sanction will be brought to the notice of the legislature by specific inclusion in the Supplementary Estimate. Pending approval of the Legislature, necessary funds will be provided in Revised Estimate / Final Modified Appropriation 2010-11.

6. The Director of Rural Development and Panchayat Raj is authorized to draw and disburse the amount sanctioned in para 3 above to the Tamil Nadu Corporation for Development of Women Limited by means of cheque, for crediting into Personal Deposit Account as indicated in the following paragraph. The Director of Rural Development and Panchayat Raj is also requested to include this expenditure in RE / FMA / Supplementary Estimates 2010-11.

7. The expenditure sanctioned in para 3 above shall not be paid in cash, but credited to the following head of account.
